Can I Certify a Fire Door?

Thank you for your enquiry about our training packages, here's a little bit more information about the training we provide.

Aims and objectives.

We have designed and produced this training package to meet the needs carpenters, joiners and their supervisors or managers that carry out inspection checks and sign-off during and post installation and maintenance works for timber-based fire doors.

This training module provides the necessary information to help those that are responsible for checking the works and signing it off to understand the requirements in terms of the checks that should be made, the records that should be kept and the documents that should be provided to the client on completion.

All learners for this training module should be competent and knowledgeable in understanding the requirements for compliant installation, maintenance and repairs to timber-based fire doors. Whilst it is not an absolute requirement it is recommended that learners for this training module should have successfully completed the relevant fire door installation and/or fire door maintenance training.

Delivery.

This training package has been designed and produced to provide equally for remote study or for traditional classroom-based delivery.

Learning materials comprise a course textbook containing images and text to describe the mandatory requirements, relevant guidance, documents for inclusion and the procedure for making the necessary checks and completing sign-off, as well as the same information on USB stick including voiced commentary.

To access the content from USB stick the delegate will require access to a suitable device running either Windows or Mac software.

An end of training examination must be passed in order for a certificate of achievement to be provided.

Content.

- Signing off. Here we look in detail at the practical process of checking and signing-off of the installation works and/or maintenance & repair works for timber-based fire doors.
- Handover to the client. Here we describe what documents should be provided to the client on completion.
- The final exam. Here we describe what happens in the examination.
